Responsibilities also include managing product stock levels, controlling purchases within budget constraints, and maintaining the highest standards in the presentation of the yard and equipment. Additionally, the Site Supervisor is involved in forklift and loader operations.

# **Details of key roles and responsibilities**

## 1. Ensure compliance with the ASQ Document Management System (Operational and WHSE)

The Site Supervisor is responsible for complying with all ASQ policies and procedures according to our Operational and WHSE Management Systems.

Responsibilities include, but are not limited to:

- Adhering to ASQ policies and procedures
- Ensuring workers adhere to ASQ policies and procedures
- Compliance with the ASQ WHSE Management System (Site Inductions, Hazard Reporting, Take 5s, Incident reporting, Risk assessments, SWPs, Participate in training etc.)
- Preparing/attending toolbox talks where required
- Attending and coordinating toolbox meetings when required
- Liaising with the HR Manager and Safety Consultant where required
- Liaising with Premix manager and Sales Manager when required

# 2. Management of site workers

The Site Supervisor is responsible for managing all workers at the Premix site.

Responsibilities include, but are not limited to:

- Managing site rostering, ensuring skills and cost efficiency are considered
- Managing performance issues
- Liaising with Premix manager in performance reviews
- Training, developing, and mentoring all workers as required
- Managing uniform and PPE gear as required
- Regularly engaging in communication and meetings with workers
- Relieving workers where required

## 3. Overseeing the daily operation of the site

The Site Supervisor is responsible for overseeing the safe, efficient, and effective operation of the site.

Responsibilities include, but are not limited to:

- Ensuring the daily operation of the site runs according to ASQ WHSE Management system following procedures/tasks (such as Opening/Closing of site, Prestart plant and equipment, Sales/Purchases, Stock entering Customer deliveries/truck scheduler, cash reconciliation and banking etc.)
- Phone answering and ordering
- Use of U-Batch system
- Use of company emails
- Completion of all necessary paperwork when applicable
- Ensuring workers provide a high level of customer service
- Ensuring products are maintained to a high standard and in optimal conditions
- Ensuring workers maintain a clean and orderly workplace
- Relief loader and truck driving when required
- Use of forklift when required
- Fault reporting of plant and equipment
- Assisting in maintenance of plant and equipment

Administration of ASQ One Hub systems, including order numbers and invoice approval

## 4. Operations of the concrete plant

The Site Supervisor is responsible for ensuring the smooth operations of the concrete plant.

Responsibilities include, but are not limited to:

- Maintaining inventory including both internal and external stocks
- Scheduling of concrete agitator trucks
- Assist in plant maintenance and repairs including mobile plant, equipment
- Ensure documentation is completed and sent to the manager daily
- Ensure yard is kept to the highest standards in cleanliness
- Ensure product stocktake is accounted for
- Other adhoc concrete batching duties as and when required

## 5. Loader/Forklift Operations of the concrete plant

- Drive the wheel loader to ensure customer deadlines are met
- Use of loader to push up and maintain incoming stocks and stockpiles
- Loading of truck and trailers when required
- Unloading and loading of pallets into freight trucks
- Relief driver for concrete agitator trucks as required
